# Support for Pioneering Research Initiated by the Next Generation (SPRING) - Doctoral Student Support Project – Application Guideline [AY2025]

The University of Tsukuba has been selected by JST (Japan Science and Technology Agency) as one of the universities / colleges that leads promising students through their program "Support for Pioneering Research Initiated by the Next Generation (SPRING)." Through this program, the University provides financial support (living & research allowance, hereinafter referred to as Research Fellowship) to our promising doctoral students in the form of grants. The overview of the JST project "SPRING" and our application requirements are shown below.

Please note that new applications for "University Fellowship Establishment Program (Fellowship)" will no longer be accepted from 2025 onwards.

## Purpose of the Project

- Supporting PhD students to devote themselves to unrestricted, challenging and interdisciplinary research projects
- Supporting the students to devote themselves to their own research by covering their living expenses.
- Assisting promising students to become doctorate degree holders who are ready for a variety of diverse and important careers

#### 2. Students who are not Eligible (no matter the category)

#### Those who apply to the following conditions are NOT ELIGIBLE to apply for this project in 2025:

- ① The research fellows of the program "Research Fellowship for Young Scientists" (Japan Society for the Promotion of Science)
- ② The recipients of MEXT Scholarship
- ③ The recipients of the scholarship granted by the government of their home countries
- ④ Those who have received a sufficient level of scholarship (more than 2.4 million yen/year) related to living expenses.
- (5) Those who work for a company and receive a sufficient and stable level of income for living expenses (more than 2.4 million yen/year)\*
- 6 Those who are on "Leave of Absence" as of April 2025
- $\oslash$  Individuals who are enrolled beyond the standard period of study
  - \* However, it shall not prevent that students to engage in TA/RA (including RA of JST "Fusion Oriented Research for disruptive Science and Technology (SOHATSU)" project) activities under appropriate supervision and within the scope that does not interfere with their own research activities, and to receive appropriate compensation for this.

#### **3. Application Requirements**

- Highly motivated students who are keen on developing their career path
- Those who aim to work hard and productively in unique and interdisciplinary research studies that can contribute SDGs (Sustainable Development Goals)
- Those who will try to interact with companies or making chances to work in various fields by:
  - Participating in long term internship / Working as research staff
  - Participating in social events such as company networking events, or gatherings for PhD students
  - Having some experience abroad such as through study-abroad or other experience

#### 4. Fellowship Amount

#### **Class 1.** <u>Particularly promising students</u> (aprx.25% out of recipients):

2.9 million yen (2.4 million yen for living (Research Incentive Fund), 500,000 yen for research)

#### Class 2. Promising students (aprx.75% out of recipients) :

2.72 million yen (2.22 million yen for living (Research Incentive Fund), 500,000 yen for research)

#### 6. Submission Period

April 8 (Tue),2025 to April 14 (Mon), 2025 \*Late applications cannot be accepted.

#### 7. Awardee Tasks

#### (1) Mandatory Tasks

- To take the online course "APRIN research ethics e-learning program (eAPRIN)" (Selected students will be notified separately on how to attend)
- To submit the reports: "Research Progress Report" and "Final Reports"
- To participate in the research presentation hosted by the program
- · To submit the pledge to agree with sharing your email address with the JST
- The University is expected to report follow-up of the awardees' career for more than 10 years, so everyone must register with "JGRAD".
- To register for the matching system for Job-type research internships
- To register for "PhD x FUTURE.", a matching system for young researchers
- To acquire more than one credit in the Graduate General Education Courses Program

#### (2) Tasks to be implemented as far as possible

To develop your career path proactively, please implement the following tasks as far as possible:

- Study abroad (or some overseas experiences equivalent to studying abroad)
- To participate in the mutual exchange activities between Japanese students and international students through the campus mini-camp (tentative; cooperative study and exchange meetings involving overnight stay)
- To engage in long term internship / working as research staff
- To participate in social gatherings of awardees conducted by JST
- To participate actively in events / activities offered by the Project Officer of the university

#### 8. Revocation of Fellowship

If the Project Officer determines that the awardee has met any of the conditions described below, the awardee will be given guidance on improvement. If the awardee does not show improvement, this fellowship will be terminated.

- Not accomplish the assigned tasks
- Not proceeding research as planned

In cases such as a false application or research misconduct, the approval will be revoked and the recipient will have to return the whole amount of the fellowship already paid.

#### 9. Others

- (1) All recipients have the duty of giving their recent career reports. The University is expected to report follow-up of the recipients for more than 10 years.
- (2) The selection results (the recipient of fellowship) will be disclosed on the University website.
- (3) Research Incentive Fund (equivalent to living expenses) as of a part of the fellowship, will be considered miscellaneous income. Therefore, it will be necessary to declare it in the following year.

#### [References]

(1) Income Tax (Allowance for Dependents)

A tax allowance per each dependent is granted to the taxpayer who has dependent family. If the dependent member's income (January to December) exceeds JPY 480 000, the tax allowance cannot be taken in the following year. In addition, the residence tax of the following year will be calculated according to the income of the year

#### (2) <u>Health Insurance – Family Membership</u>

The annual income of a dependent family member must be less than JPY 1.3 million. Since the living allowance is considered income, the recipients will need to join the National Health Insurance (国民健康保険) themselves.

(3) <u>Tuition Fee Exemption</u>

The major factors of selection are usually finance and the applicants' family structure. Depending on the applicant's incomes (including the fellowships), the waiver may not be granted.
